If hours are not completed, member will be required to purchase a non-working membership for the following year. After the probationary year is up, the member will have the option to be a working or non-working member and pay the required fees.

Work hours may be done during MBB scheduled work days/evenings, indoor or outdoor 3-D tournaments, including set up or tear down or during youth archery league. All other hours must be pre-approved by a board member to be accepted. **Archery league setup by your team, will not be included in membership working hours.**

**Waiver/Release**  
**ARCHERY CLUB WAIVER AND RELEASE OF LIABILITY**  
**READ BEFORE SIGNING**

In consideration of being allowed to participate in any way in **Missouri Basin Bowmen** events and activities, the undersigned acknowledges, appreciates, and agrees that:

- 1) The risk of injury from archery and other known and unknown events and activities and/or the use of the related buildings, structures, equipment, automobiles, firearms, weapons, ATV's, boats, tree stands, roads, bodies of water, land and all other real and personal property whether owned by archery club or others is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
- 2) I acknowledge and agree that the use of archery equipment, firearms and other weapons by myself or others on club premises or otherwise are inherently dangerous and high-risk activities whether such archery equipment, firearms or weapons are discharged by myself or others; and
- 3) I KNOWLINGLY AND **FREELY** ASSUME ALL SUCH RISKS, both known and unknown, **EVEN IF ARISING FROM THE NEGLIGENCE** OF ALL RELEASEES or others, and assume full responsibility for my participation; and,
- 4) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- 5) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS Missouri Basin Bowmen**, its officers, directors, officials, agents, employees, volunteers, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of real property used to conduct the events and activities ("RELEASEES"), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW** except to the extent there is insurance coverage (other than that which may be provided by MBB) for motorized vehicles.
